THE 42 NEW HOUSEHOLDS IN 2020 WAS THE BUSIEST AND MOST PRODUCTIVE YEAR IN ITS HISTORY. IN ADDITION TO THESE 321 OCCUPIED AFFORDABLE OWNERSHIP HOMES, THERE ARE ALSO FOUR RENTAL PROPERTIES, THE CLCLT OFFICE BUILDING AND SEVERAL ADDITIONAL PROPERTIES UNDER DEVELOPMENT IN MINNEAPOLIS ALL WHICH ARE OWNED BY THE CLCLT. SOME STAFF HAVE NEEDED TO MAINTAIN A WORKING FROM HOME FOR HEALTH AND FAMILY REASONS. THROUGH THE FALL, TWO CLCLT STAFF CONTRACTED COVID FROM OUTSIDE THE OFFICE. TO TAKE NECESSARY PRECAUTIONS, THE CLCLT NEEDED TO CLOSE THE OFFICES TO THE OUTSIDE FOR TWO, TWO-WEEK PERIODS DUE TO THE POSITIVE TESTS OF TWO STAFF MEMBERS.

CONSTRUCTION COSTS HAVE GONE UP SIGNIFICANTLY OVER THE PAST YEAR. BOTH CONSTRUCTION LABOR AND MATERIALS ARE SIGNIFICANTLY HIGHER THAN A YEAR AGO. ADDING ADDITIONAL STRESSES TO THE AFFORDABLE HOMEOWNERSHIP SECTOR, PUBLIC FUNDERS HAVE BEEN RELUCTANT TO INCREASE THE PER UNIT AFFORDABILITY OR DEVELOPMENT GAP SUBSIDY. FOR THESE REASONS, THE CLCLT IS PRIORITIZING THE COMPLETION OF MANY HOMES UNDER CONSTRUCTION OR REHABILITATION TO LIMIT THE FINANCIAL EXPOSURE TO THE ORGANIZATION. THE CLCLT IS ESTIMATING THAT UP TO 10% OF THE HOMEOWNERS IN CLCLT HOMES ARE AT POTENTIAL RISK OF FORECLOSURE IN LATE 2021 DUE TO THE NEGATIVE FINANCIAL IMPACT OF COVID ON LOWER INCOME HOUSEHOLDS. ON THE NHSM LENDING AND SERVICING FRONT THE ORGANIZATION HAS OFFERED FORBEARANCES TO ALL LOAN CLIENTS. APPROXIMATELY 10% OF THE NHSM BORROWERS UTILIZED THE FORBEARANCE OPTION IN 2020. FOR THE MOST PART, CLCLT HOMEOWNERS HAVE BEEN ABLE TO STAY IN THEIR HOMES AND MAKE LEASE FEE PAYMENTS TO THE CLCLT.

IN 2020 THE CLCLT SPONSORED OVER 30 CLCLT ORIENTATIONS. THE NUMBER OF ATTENDEES AT THESE SESSIONS HAS SIGNIFICANTLY INCREASED IN 2020. THROUGH THESE OUTREACH OPPORTUNITIES, THE CLCLT ESTIMATES IT WAS ABLE TO INFORM OVER 2,000 HOUSEHOLDS ABOUT THE COMMUNITY LAND TRUST MODEL AND CLCLT HOMEOWNERSHIP OPPORTUNITIES IN 2020. THE CLCLT BOARD OF DIRECTORS FORMALLY ADDED A COMMERCIAL LAND TRUST PROGRAM TO ITS WORK IN FEBRUARY 2019 AND HIRED A PROGRAM DIRECTOR FOR THE PROGRAM IN OCTOBER OF 2019. THROUGH 2020, THERE HAS BEEN EFFORTS SOLIDIFY THE COMMERCIAL LAND TRUST OPERATING DOCUMENTS WITH THE GOAL OF BRINGING THE FIRST COMMERCIAL LAND TRUST PROPERTIES INTO THE ORGANIZATION IN 2021.

THE COMMERCIAL LAND TRUST PROGRAM, THE CITY OF LAKES COMMUNITY REALTY LLC, AND SEVERAL OF THE CLCLT PROGRAMS INCLUDING CLCLT DEVELOPMENTS, THE HOMEBUYER INITIATED PROGRAM (HIP), PROJECT: SUSTAINED LEGACY (P:SL), THE AFRICAN AMERICAN CLT, AND ALL ARE EXAMPLES OF THE CLCLT EXPANDING THE USES OF THE COMMUNITY LAND TRUST IN MINNEAPOLIS.

IN 2020, THE CITY OF MINNEAPOLIS CITY COUNCIL APPROVED A POLICY STATING THAT ANY OWNERSHIP SUBSIDY OR SALE OF LAND TRIGGERED ITS NEW PERMANENT AFFORDABLE HOUSING REQUIREMENTS. IT ALSO INITIATED ITS OWNED SHARED EQUITY PROGRAM (2%, FIXED-RATE APPRECIATION MODEL). THE CLCLT WAS

SELECTED AS ONE OF TWO ADMINISTRATORS OF THIS PROGRAM. THE CLCLT IS ALSO OFFERING ITS CURRENT 25% APPRAISAL-BASED MODEL AS AN ALTERNATIVE TO DEVELOPERS. MUCH WILL BE LEARNED OF THE IMPACT OF THIS POLICY IN 2021, BUT THE CLCLT BELIEVES IT MAY CREATE ADDITIONAL CLCLT UNITS IN 2021 AND BEYOND.
